- boards have faculty members (0 who vote)



#### **SELECTION**

- 0 boards have members selected by a general election
- 11 boards have members selected by the governor
- boards have members selected by the state legislature



#### **PROCESS**

- 11 boards have an external vetting process for members
- 11 boards have a formalized removal process for members



#### **REQUIREMENTS**

- boards require their members to be state residents
- 0 boards require some members to live in a certain region of the state

#### **INTERESTING FACT**

Alumni voices on boards are highly valued in Massachusetts. At least one appointee to each institution board must be an alumnus of that institution, and At least five gubernatorial appointments to the University of Massachusetts Board of Trustees must be alumni (with one from each campus). All appointments to the board are vetted by an external screening agency.
