ABOUT THE BOARDS

MEMBERSHIP



- 2 boards have student members (2 who vote)
- 1 boards have faculty members (0 who vote)

SELECTION



- 0 boards have members selected by a general election
- 2 boards have members selected by the governor
- 1 board has members selected by the state legislature

PROCESS



- 0 boards have an external vetting process for members
- 0 board has a formalized removal process for members

REQUIREMENTS




- 0 boards require their members to be state residents
- 0 boards require some members to live in a certain region of the state

INTERESTING FACT

Four members of the Board of Regents of Higher Education are appointed by individual legislative leaders. The president pro tempore must appoint an alumnus of the regional community-technical college system; the minority leader of the Senate must appoint a specialist in K-12 education; the speaker of the House of Representatives must appoint an alum of the Connecticut State University System; and the minority leader in the House of Representatives must appoint an alumnus of Charter Oak State College.
