ABOUT THE BOARDS

MEMBERSHIP



- 8 boards have student members (7 who vote)
- 1 board has faculty members (1 who votes)

SELECTION



- 0 boards have members selected by a general election
- 8 boards have members selected by the governor
- 0 boards have members selected by the state legislature

PROCESS



- 0 boards have an external vetting process for members
- 2 boards have a formalized removal process for members

REQUIREMENTS



- 5 boards require their members to be state residents
- 5 boards require some members to live in a certain region of the state

INTERESTING FACT

Several of Indiana's governing boards speak to gender diversity among members. For instance, Indiana State University Board of Trustees specifies that at least one member be a woman, whereas Ball State University Board of Trustees requires that no more than six of the non-student members can be of the same gender.
