ABOUT THE BOARDS

MEMBERSHIP



- 10 boards have student members (10 who vote)
- 10 boards have faculty members (11 who vote)

SELECTION



- 0 boards have members selected by a general election
- 10 boards have members selected by the governor
- 0 boards have members selected by the state legislature

PROCESS



- 10 boards have an external vetting process for members
- 9 boards have a formalized removal process for members

REQUIREMENTS




- 0 boards require their members to be state residents
- 1 board requires some members to live in a certain region of the state

INTERESTING FACT

In appointing members to the Council of Postsecondary Education, Kentucky law requires that the governor assure broad geographical and political representation of the board, equal gender representation, and a reflection of the state's minority population on the board.
