INTERESTING FACT

No members of the Mississippi Community College Board can be education professionals. And while two members of that board are appointed from each congressional district, not two members can reside in the same junior college district.

MEMBERSHIP



- 0 boards have student members (0 who vote)
- 0 boards have faculty members (0 who vote)

SELECTION



- 0 boards have members selected by a general election
- 2 boards have members selected by the governor
- 0 boards have members selected by the state legislature

PROCESS



- 0 boards have an external vetting process for members
- 1 boards have a formalized removal process for members

REQUIREMENTS



- 2 boards require some members to be state residents
- 2 boards require some members to live in a certain region of the state
