ABOUT THE BOARDS

MEMBERSHIP



- 8 boards have student members (0 who vote)
- 0 boards have faculty members (0 who vote)

SELECTION



- 0 boards have members selected by a general election
- 12 boards have members selected by the governor
- 0 boards have members selected by the state legislature

PROCESS



- 0 boards have an external vetting process for members
- 0 boards have a formalized removal process for members

REQUIREMENTS



- 11 boards require their members to be state residents
- 11 boards require some members to live in a certain region of the state

INTERESTING FACT

Board membership in Missouri is highly defined though each board has distinct requirements. Regulations from across the state may limit the number of political party affiliates and specify a minimum number of political party affiliates. Geography is often considered and can be defined by congressional districts, counties, clusters of counties, and institution-specified statutory-defined regions.
