## ABOUT THE BOARDS

### MEMBERSHIP



- 10 boards have student members (11 who vote)
- 1 board has faculty members (1 who votes)

### SELECTION



- 0 boards have members selected by a general election
- 11 boards have members selected by the governor
- 0 boards have members selected by the state legislature

### PROCESS



- 0 boards have an external vetting process for members
- 11 boards have a formalized removal process for members

### REQUIREMENTS



- 0 board requires its members to be state residents
- 0 board requires some members to live in a certain region of the state

## INTERESTING FACT

New Jersey state statute provides that each state college can determine its board size and composition so long as it has between seven and fifteen members, not including the president.
