MEMBERSHIP



- 0 boards have student members (0 who vote)
- 0 boards have faculty members (0 who vote)

SELECTION



- 0 boards have members selected by a general election
- 10 boards have members selected by the governor
- 10 boards have members selected by the state legislature

PROCESS



- 0 boards have an external vetting process for members
- 5 boards have a formalized removal process for members

REQUIREMENTS



- 5 boards require their members to be state residents
- 9 boards require some members to live in a certain region of the state

INTERESTING FACT

The Clemson University Board of Trustees is composed of six members appointed by the state legislature and seven self-perpetuating members. Originally identified in Thomas Green Clemson's will, self-perpetuating members serve for life and have been selecting their own successors since 1889.
