## ABOUT THE BOARDS

### MEMBERSHIP



- 7 boards have student members (7 who vote)
- 0 boards have faculty members (0 who vote)

### SELECTION



- 0 boards have members selected by a general election
- 8 boards have members selected by the governor
- 0 boards have members selected by the state legislature

### PROCESS



- 0 boards have an external vetting process for members
- 8 boards have a formalized removal process for members

### REQUIREMENTS

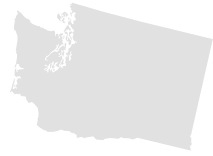


- 1 board requires its members to be state residents
- 1 board requires some members to live in a certain region of the state

## INTERESTING FACT

Members of institutional boards can only be removed by the governor for “inefficiency, neglect of duty, or malfeasance in office.” To remove a member, the governor must serve the trustee with a petition highlighting the cause, and a superior court tribunal will hear arguments and decide the case.
